AND

- be holder of the LANTRA *Beginning Falconry* Award, or an equivalent award from a recognised accreditation organisation,

**PLUS one or more of the following:**

- Full member of a recognised Falconry Club (which distinguishes between Associate/Apprentice and Full Members);

AND/OR

- Recipient of a current Zoo License for a collection which includes Birds of Prey;

AND/OR

- Possession of an Animal Care or Animal Management, at least at level 2, or similar award from a recognised awarding body;

AND/OR

- A qualified veterinary nurse or veterinary surgeon;

AND/OR

- Holder of a recognised teaching or training qualification at least at Level 3;

OR

- Can present a portfolio evidence of advanced practice in Bird of Prey care, management and falconry with witness statements and testimonials.

**NB - Documentary *evidence* must be provided in all cases.**

**In addition the names and addresses of two referees must be included with your application (see below)**

Regretfully, applications from those who have unspent convictions under legislation relating to animal welfare, wildlife conservation or other convictions relating to birds of prey cannot be considered.
